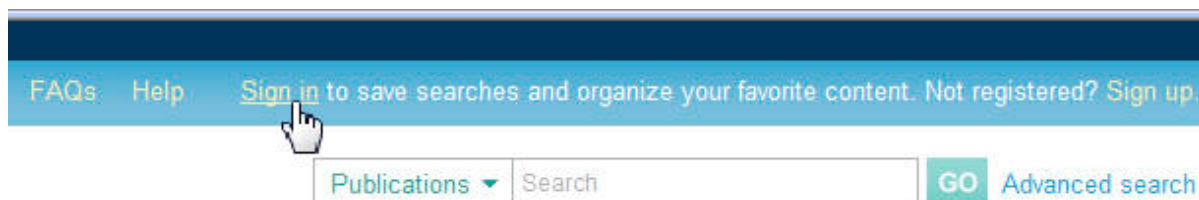
Custom Books Guide

This book provides step-by-step instructions for creating a custom book. A custom book allows you to compile your selection of content items into a PDF. In this guide you will learn how to:

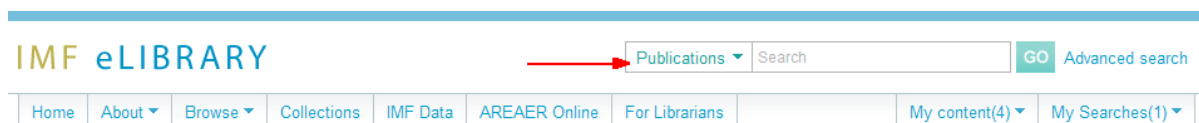
- Create a personalized area.
- Save searches and content.
- Tag your content with keywords.
- Select and arrange content to design a book.

Creating Your Personalized Area

Sign in to your personalized area. If you have not registered, click on Sign up. With your personal account, you will be able to save, organize, and customize your selected content. To register, simply follow the instructions by providing an e-mail address and a new password. These credentials will allow you to access “My eLibrary” at any time.



To create a custom book, you will need to search for and save content that you would like to include in your custom book. Use the simple or advanced search to find new results. For search instructions see the Startup Guide.



Saving Content and Searches

From your search results, click on a title to see the detailed description of the book, chapter or paper. Click on Save at the top of the screen to store in your personalized section. Use “Previous” and “Next” to move to other results.

Global merchandise trade sharply declined in late 2008 and early 2009, and some press and financial market reports assigned a large role for the decline to trade finance. However, the available evidence suggests that shocks to trade finance were not the major factor in the decline in trade. Surveys of commercial banks by the IMF and others found that while bank-intermediated trade finance fell in value during the crisis, it fell by less than merchandise trade. As a result, the share of world trade supported by bank-intermediated trade finance increased despite higher pricing margins. Other explanations appear to account for the bulk of the reduction in international trade.

If you go “Back to Results” and then click on Save, you will be able to save your search to run again in the future.

Tagging Your Selections

Each time you save a book, chapter, paper, or search, you will be prompted to assign a tag. Tags are terms that you assign to organize your selections in “My eLibrary”. They can be the name of a topic or a country or region of interest. For example, the tag could be named “Inclusive Growth” or “Europe”.

- You can use existing tags from previous searches by checking the box next to the tag.
- You can add new tags on the blank line.
- You can choose not to use any tags at all.

Creating a Custom Book

When you have finished searching and selecting, click on “My eLibrary” at the top of the page. You will see all of your saved content and searches. The lists also include anything you saved in previous sessions.

**Please note:* You cannot create a custom book using an entire book or journal. This will produce an error. To ensure that you are selecting only chapters and articles, use the Refine by checkboxes for chapter and article in the left column on the search results page.

Action options on the right hand side allow you to edit tags, cite a selection, or delete a selection. (1)

To create a custom book, place a checkmark in the box next to the item(s) you want in the book, then Add to Custom Book. (2)
